#### Did you know?

This shift is **no longer limited to Defence** alone.

Where work involves sensitive systems, protected information, or personal and medical-in-confidence data, an NV1 clearance is rapidly becoming the standard requirement.

This includes work associated with:

- Department of Defence
- Australian Taxation Office (ATO)
- Services Australia
- NDIS and other agencies managing personal or health-related data

In practical terms, even roles that were historically considered “non-sensitive” are now falling within clearance-required environments.

## Recommended Clearance Level

We recommend Negative Vetting Level 1 (NV1) as a minimum.

NV1 is the **most commonly requested clearance** level across the Australian Government and Defence. It provides access to a wide range of classified environments and roles, making it the strongest baseline investment for individuals and organisations entering or expanding within the Defence sector.

## Why Start Now

The Australian Government Security Vetting Agency (AGSVA) currently advises average processing timeframes of approximately **70 business days for NV1 clearances**. Starting early ensures you are opportunity-ready — positioned to accept work immediately rather than missing out while clearance is pending.
